5. DISCUSSION AND POSSIBLE ACTION TO APPROVE FY13-17 METROPOLITAN TRANSPORTATION IMPROVEMENT PROGRAM (MTIP) AMENDMENT 3

Chris Bridges, CYMPO Administrator (Task #3.0)

Mr. Bridges discussed the reason for the changes as well as having an 8- year TIP. He stated he would recommend expanding it to 10- years once the formatting is adjusted.

Member LaJeunesse explained the SR69 signal replacement. Chairman Davis questioned the time frame; Member LaJeunesse indicated it would start this summer

Mr. Bridges explained there is a possible duplication of the funding for Great Western. It is possible Yavapai County may provide funding for the construction. That would be the purpose of removing from the TIP as well as there is not funding available. Member Straub related concerns removing an item from the TIP.

Discussion was held regarding a 10-year TIP versus an 8-year TIP. Member Glendening responded the P2P will mandate a 10-year TIP. Discussion was held about the TIP in general.

Chairman Davis discussed SR169 to Fain Road. Mr. Bridges related the Executive Board's priority is the widening of SR69 and utilizing the funding from SR169 to Fain Road project. Member Glendening indicated ADOT is beginning to look at spending money on studies where there is not funding available for construction.

MOTION

Proxy Member Willett presented a motion to expand the TIP from 5 years to 10 years and to recommend the Executive Board approve Amendment 3 of the MTIP omitting the deletion of Great Western Corridor DCR, adding it to FY21 and FY22. The Motion was seconded by Vice-Chairman Tkach.

Comments were made by Byron Jaspers, Yavapai County and Town of Prescott Valley Councilwoman Mallory.

VOTE ON THE MOTION

The vote on the motion was unanimous.

6. DISCUSSION AND POSSIBLE ACTION TO APPROVE SENDING A LETTER TO ARIZONA DEPARTMENT OF TRANSPORTATION REGARDING REGIONAL PROJECTS

Mr. Bridges recommended including SR89 Widening Project as well as the SR69 Widening Project. He related these two projects are a priority. Proxy Member Willett questioned what the letter was to specifically state. Mr. Bridges responded; Scoping for SR69 and continue with the SR89 project.

Mr. Bridges provided an update of the Work Plan and the Long Range Transportation Plan (LRTP).

Member questioned the use of the CYMPO SPR funds and PL as there appears to be a Carry-Over. Mr. Bridges responded the FY11 & 12 SPR funds are to be obligated for the LRTP and FY14 for Operations of the MPO.

Chairman Davis discussed the match for the LRTP, relating the entities are fiscally constrained.

Mr. Bridges related the scope for the LRTP should be smaller than anticipate; keeping the costs less.
