- Classifying the SR89A Spur as a major arterial as one of the future projections
- On pages 26, 27, and 30 32 make necessary corrections; primarily the correct sponsor

Member Glendening questioned if the information presented on page 26 of the draft report coincides with the 2006 report. Mr. Bridges responded yes and that the primary changes in the report are all of the population updates. There will not be additions or deletions of projects.

Member McConnell suggested the project "Side Road" reflect in the report as "Granite Dells Parkway"; due to the name change. Or reflect Granite Dells Parkway (Side Road).
