4. DISCUSSION AND POSSIBLE ACTION TO RECOMMEND CONSULTANT(S) FOR THE CYMPO REGIONAL LONG RANGE TRANSPORTATON PLAN TO THE EXECUTIVE BOARD

Chris Bridges, CYMPO Administrator (Task #4.0)

Mr. Bridges related CYMPO received seven (7) responses to the Request of Statement of Qualifications by June 5, 2013. They were from: AECOM, Ayres Associates, HDR, IBI Group, Jacobs Engineering Group, Inc., Parsons Brinckerhoff, and Wilson and Company. All applications were reviewed by a Selection Panel on June 12, 2013. The preliminary evaluation among the panel was AECOM, HDR and Jacobs Engineering Group were the top three (3) submissions. June 26, 2013 the Selection Panel conducted interviews with those top three candidates after which it was determined AECOM was the top scoring firm followed by HDR then Jacobs Engineering Group.

Mr. Bridges requested the M-TAC move forward with a recommendation to the Executive Board to begin negotiations with the highest rated firm and should negotiations fail to move on down the line with the remaining firms.

Chairman Davis asked if the M-TAC would have opportunity to review the scope of work and fee. Mr. Bridges explained the contract would have to be drawn up by the consultant's attorney and should include specific federal language as set forth by ADOT. Once CYMPO is in receipt of the contract/scope of work, it would be distributed to the M-TAC for comment.

Vice-chairman Tkach asked if a schedule of fees would be included in the scope of work, Mr. Bridges replied, yes it would.

Member Straub asked what AECOM's schedule was. Mr. Bridges responded it was about twelve (12) months. Mr. Straub confirmed it would take until September to October of next year 2014 for a finished product. Mr. Bridges agreed.

Member Kimball presented a motion to recommend the Executive Board approve CYMPO staff to begin contract negotiations with AECOM, the highest ranked firm. Motion was seconded by Member Straub.
