## 4. AMENDMENT ONE FY12-16 METROPOLITAN TRANSPORTATION IMPROVEMENT PROGRAM (MTIP)

Chris Bridges, CYMPO Administrator (Task #3.0)

The following are the changes and/or additions to the FY12-16 MTIP that were presented to the M-TAC committee. The changes and/or additions need to be indicated on the TIP to receive funding.

- Safe Routes to School Prescott Unified School District, Non-Infrastructure FY12 \$111,936
- 2) Safe Routes to School Humboldt Schools, Non-Infrastructure FY12 \$28,211
- 3) Fain Rd SR 69 SR 89A New FY12 \$30 million
- 4) Transit Sheet adjustments:
- Delete all activity for FY11 and FY12 except the Chino Valley Transit

In addition to Fain Road widening, the State Transportation Board approved the following:

- 1) SR 89A to Ruger Rd (MP321) –moved from FY13 to FY14, change from \$25 million to \$15 million
- 2) Ruger Rd to So. Chino Valley (89A to MP321) moved from FY13 to FY16 \$10 million
- 3) White Spar Road (Bikeway/Pathway enhancements) moved from FY11 to FY12 and combined into one; increased from \$3,721 million to \$4,652

Staff recommendation is as follows:

- 1) Chino Valley/ADOT SR89/Perkinsville Rd Design & Construction move from FY14 to FY12 \$633,000 STP / \$367,000 Local: Total \$1 million
- Chino Valley / ADOT SR 89/Perkinsville Rd Design & Construction move from FY15 to FY13 \$633,000 STP/ \$367,000 Local: Total \$1 million
- 3) SR89A to MP 321move to FY14 \$15 million
- 4) SR89A to MP 321 move to FY15 \$10 million

Mr. Bridges indicated there are additional changes. The Section 5310, 5316 & 5317 will be moved to the Transit sheet.

Member Davis requested the project names on the sheet match exactly to what ADOT has indicates the name is.

Chairman Grittman expressed concern that the SR89 Widening project is to be performed in FY14 & FY16 as there may not be funding available in FY16. He stated the traffic volume exceeds the volume of I17 and Cordes Junction. There is a safety issue.

Vice Chairman Bourdon presented a motion to approve FY12 -16 MTIP Amendment One with the noted changes and forward to the Executive Board with the recommendation to approve. The motion was seconded by Member Davis.

Mr. Bridges related The City of Prescott received the following six (6) responses on June 30, 2011, to the RSOQ:

- LSA Associates, Inc.
- HDR Engineering, Inc.
- Wilbur Smith Associates
- Wilson & Company
- Jacobs Engineering Group, Inc.
- AECOM

The top three were selected and interviewed. From the interviews they were ranked as follows:

- 1. Jacobs Engineering
- 2. AECOM
- 3. HDR Engineering

Mr. Bridges stated the Executive Board needs to approve on the 17<sup>th</sup>. Mr. Davis requested the timeline as previously indicated accompany the recommendation.

Chairman Grittman explained that FHWA required an update of the Long Range Plan and agreed to this miniupdate.

### 6. PROPOSED FUTURE AGENDA ITEMS

Chris Bridges, CYMPO Administrator (Task #1.2)

Mr. Bridges explained that at this time there are no items for the September agenda unless the MPO has more to move forward with the HSIP.

Chairman Grittman questioned of the committee needed to discuss disbanding the T-TAC committee. Vice-Chairman Bourdon related that should be an Executive Board decision. Discussion was held regarding the purpose of the T-TAC and keeping it intact or merging with the M-TAC. It was also discussed to take it to the Executive Board as a discussion item. It was noted that items for the T-TAC could potentially be brought to the M-TAC for discussion or approval.

Member McConnell questioned if it had been determined if there is a representative from Dewey- Humboldt at this time. Mr. Bridges related he had not received any information at this time and that the Town is still a member and has to be counted as part of the quorum of the M-TAC.

### 7. AGENCY UPDATES

Agency updates were given by:

Norm Davis, Town of Prescott Valley; Phil Bourdon, Yavapai County, Craig McConnell, City of Prescott and Charla Glendening, ADOT MPD. Mr. Davis also announced that the Town of Prescott Valley will be having a ribbon cutting after September 1<sup>st</sup> for the Robert Road widening and September 15<sup>th</sup> for the Highway 69 Multi-Use Path. The Multi-Use Path was funded with a Transportation Enhancement grant.

Ms. Glendening announced that there will be an ADOT/local officials meeting in the Prescott Area in October. Invitations are going out soon.

### 8. MISCELLANEOUS ANNOUNCEMENTS & CYMPO UPDATES

Mr. Bridges made the following announcements:

- 1. Information on the Reauthorization Bill is still in Congress and will not be discussed until they return in September.
- 2. Discussed the new draft format for the Metropolitan Transportation Improvement Program (MTIP). It is consistent with the other COGs and MPOs and easier to read.

Mr. Davis announced there will be a public meeting in late September for the Fain Road/I17 Corridor Study and requested it be on a future agenda for the Executive Board.
