5. PEDESTRIAN SAFETY

Michael Sanders, ADOT

ADOT is developing a pedestrian safety action plan for the State Highway System to reduce the frequency of pedestrian fatality and injury crashes. The action plan will take identified countermeasures and put them into a practical and achievable strategy that allows progress to be measured over time. Creating the action plan will be the culmination of effective stakeholder involvement, problem identification, and prioritization of solutions. The key is to develop an action plan that effectively focuses resources on making the changes that reduce the greatest number of severe injury crashes.

This Federal nationwide program identified the top 15 states with higher than the national average of pedestrian fatalities and injuries; followed by identifying focus cities where fatal pedestrian accidents were greater than 2.5%. The State of Arizona and the City of Phoenix both exceeded the parameters of the initial study and have been designated as "focus" areas.

Stemming from this designation, the Federal program provided workshops and guidance in developing a statewide pedestrian safety plan for the State of Arizona. ADOT is now taking the lead on this program for the state highway system and reaching out to all Arizona communities to assist in developing pedestrian plans by providing information and direction. This state and local 12 month project is anticipated to conclude in February/March 2009.

The Safe Routes to School program will have significantly more funding for the upcoming 2008-2009 grant cycle which PAT plans to again submit a grant for both non-infrastructure and infrastructure projects.

Walt Matthews, Diamond Valley Community Association (DVCA) inquired about the status of the SR69 median with Member Dallas Hammit noting that ADOT is again looking at a raised curb median possibility.
