Ms. Bondy and Mr. Kennedy, with AECOM Technical Services, Inc., provided a PowerPoint presentation to review possible projects to be considered for prioritization. Ms. Bondy reviewed each project and noted the appropriate scope of work and next level of planning study for each project being considered. Members of the Executive Board and Technical Advisory committee asked clarifying questions of Ms. Bondy and Mr. Kennedy throughout the presentation.

2:10 PM: Rural Transportation Advocacy Council (RTAC) One-Time Funding *Vinny Gallegos*

Mr. Gallegos reviewed the opportunity to acquire state legislative funding for transportation projects in Greater Arizona through an initiative being led by the Rural Transportation Advocacy Council (RTAC). Noted that RTAC is requesting \$50 million for Greater Arizona, which would then be distributed based upon population percentage among each of the Metropolitan Planning Organization (MPOs) and Councils of Governments (COGs) in Greater Arizona, resulting in \$3.8 million directed to CYMPO. Mr. Gallegos reviewed projects for consideration to be prioritized as part of the RTAC funding initiative.
